Purpose of the Group: The NMTC Working Group was established to provide a platform for NMTC industry participants to work together to resolve administrative New Markets Tax Credit Program issues that are experienced by the members of the group.

Process: Novogradac & Company LLP has taken the lead to coordinate the efforts of the group. Novogradac and Company LLP also provides expertise and administrative support to the group.

Each month, members of the group participate on a conference call hosted by Novogradac and Company LLP and led by Michael Novogradac, its managing partner. Members are encouraged to participate in discussions and provide input regarding pending action items as agreed to by the members of the group. Novogradac & Company LLP also hosts a NMTC Working Group meeting at a scheduled time at each of its national NMTC conferences. Comments and suggestions are agreed to and submitted in writing directly to the IRS and the CDFI Fund based upon the group discussions. Michael Novogradac reports back to the group information he has received from follow-up with the IRS and the CDFI Fund regarding the submissions.

Benefits: Membership in the NMTC Working Group offers a number of important benefits:

- The working group provides a platform where members can collaborate on similar issues and problems and work together to solve them.
- Members have the opportunity to provide input on issues affecting the industry as a whole.
- Members have the opportunity to share the costs of resolving similar issues as a group rather than on an individual basis.
- Members have the opportunity to keep abreast of emerging issues and recommended practices in the industry.

Membership Fee:

The fee for each member is \$5,000 for twelve months.

Membership fees cover the time incurred by Novogradac & Company LLP professionals to research, collaborate and prepare written and verbal communications to the respective agencies. Each month, Novogradac & Company LLP updates the group on the status of each issue and the time that has been incurred addressing them.
