6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
7 That the Laws of Maryland read as follows:

8 **Article – Corporations and Associations**

9 1–203.1.

10 (b) A qualified business entity that is a new business entity in a Tier I [county]  
11 AREA, as defined under the More Jobs for Marylanders Program established under Title 6,  
12 Subtitle 8 of the Economic Development Article, is not subject to the fees enumerated in §  
13 1–203 of this subtitle.

14 **Article – Economic Development**

15 6–801.

16 (a) In this subtitle the following words have the meanings indicated.

17 (b) “Benefit year” means a taxable year in which a qualified business entity  
18 claims a program benefit established under § 6–805 of this subtitle.

19 (c) (1) “Business entity” means a person conducting or operating a trade or  
20 business that is:

21 (I) primarily engaged in activities that, in accordance with the  
22 North American Industrial Classification System (NAICS), United States Manual, United  
23 States Office of Management and Budget, 2012 Edition, would be included in Sector 31, 32,  
24 or 33; OR

25 (II) LOCATED IN AN OPPORTUNITY ZONE.

26 (2) “Business entity” does not include:

27 (I) a refiner, as defined in § 10–101 of the Business Regulation  
28 Article; OR

29 (II) A PERSON CONDUCTING OR OPERATING A TRADE OR  
30 BUSINESS THAT IS:

1 1. PROVIDING ADULT ENTERTAINMENT, AS  
 2 DETERMINED BY THE DEPARTMENT;

3 2. PRIMARILY ENGAGED IN RETAIL ACTIVITIES, UNLESS  
 4 THE PERSON IS OPERATING A GROCERY STORE LOCATED IN AN OPPORTUNITY ZONE;  
 5 OR

6 3. PRIMARILY ENGAGED IN THE SALE OR DISTRIBUTION  
 7 OF ALCOHOLIC BEVERAGES.

8 (d) “Eligible project” means a facility operated by a business entity in a Tier I  
 9 [county] AREA or Tier II [county] AREA.

10 (e) “Existing business entity” means a business entity that is located in the State  
 11 at the time it notifies the Department under § 6–803(c) of this subtitle.

12 (F) “GROCERY STORE” HAS THE MEANING STATED IN § 9–254 OF THE TAX –  
 13 PROPERTY ARTICLE.

14 [(f)] (G) “New business entity” means a business entity that is not located in the  
 15 State at the time it notifies the Department under § 6–803(b) of this subtitle.

16 (H) “OPPORTUNITY ZONE” MEANS AN AREA THAT HAS BEEN DESIGNATED AS  
 17 A QUALIFIED OPPORTUNITY ZONE IN THE STATE UNDER § 1400Z–1 OF THE  
 18 INTERNAL REVENUE CODE.

19 [(g)] (I) “Program” means the More Jobs for Marylanders Program established  
 20 under this subtitle.

21 [(h)] (J) “Qualified business entity” means a new business entity or an existing  
 22 business entity operating an eligible project under this subtitle.

23 [(i)] (K) (1) “Qualified position” means a position that:

24 (i) is full–time and of indefinite duration;

25 (ii) 1. EXCEPT AS PROVIDED IN ITEM 2 OF THIS ITEM, FOR A  
 26 POSITION IN A FACILITY THAT IS LOCATED IN AN OPPORTUNITY ZONE, PAYS AN  
 27 AVERAGE ANNUAL SALARY THAT EXCEEDS \$50,000; OR

28 2. FOR A POSITION IN A FACILITY ~~THAT IS NOT LOCATED~~  
 29 ~~IN AN OPPORTUNITY ZONE~~ OF A BUSINESS ENTITY DESCRIBED UNDER SUBSECTION  
 30 (C)(1)(I) OF THIS SECTION, pays at least 120% of the State minimum wage;

31 (iii) is located in a facility;

1 (iv) is newly created at a single facility in the State; and

2 (v) is filled.

3 (2) “Qualified position” does not include a position that is:

4 (i) created when an employment function is shifted from an existing  
5 facility of a business entity in the State to another facility of the same business entity if the  
6 position is not a net new job in the State;

7 (ii) created through a change in ownership of a trade or business;

8 (iii) created through a consolidation, merger, or restructuring of a  
9 business entity if the position is not a net new job in the State;

10 (iv) created when an employment function is contractually shifted  
11 from an existing business entity to another business entity in the State if the position is  
12 not a net new job in the State; or

13 (v) filled for a period of less than 12 months.

14 **[(j)] (L)** “Tier I [county] AREA” means:

15 (1) a Tier I county, as defined in § 1–101 of this article; [or]

16 (2) a county designated by the Department that is not a county described  
17 in item (1) of this subsection, not to exceed three counties; OR

18 **(3) AN OPPORTUNITY ZONE.**

19 **[(k)] (M)** “Tier II [county] AREA” means [a county] AN AREA that is not [a  
20 county] AN AREA described in subsection [(j)] (L) of this section.

21 6–803.

22 (a) A business entity may apply to the Department to enroll an eligible project in  
23 the Program if the eligible project:

24 (1) is in a Tier I [county] AREA and the business entity intends to create  
25 at least five qualified positions at the project location; or

26 (2) is in a Tier II [county] AREA and the business entity intends to create  
27 at least 10 qualified positions at the project location.

1           **(b) (1)** A new business entity may not be certified as a qualified business entity  
2 unless the new business entity:

3                   **(i)** notifies the Department of its intent to seek designation of an  
4 eligible project before establishing its facility in the State; and

5                   **(ii)** offers an ongoing job skills enhancement training program or  
6 postsecondary education program that is approved by the Department.

7           **(2)** The Department may certify a new business entity as a qualified  
8 business entity after the new business entity provides the required notice under paragraph  
9 (1)(i) of this subsection, applies to the Department under paragraph (3) of this subsection,  
10 and establishes and operates an eligible project.

11           **(3)** A new business entity shall submit to the Department an application  
12 containing at least the following information:

13                   **(i)** the anticipated date of the establishment and initial operation of  
14 the facility and the nature of its operations;

15                   **(ii)** the expected location of the facility;

16                   **(iii)** the estimated number of qualified positions to be created and  
17 qualified employees to be hired and the anticipated payroll of the new qualified employees;  
18 and

19                   **(iv)** any other information the Department requires.

20           **(c) (1)** An existing business entity may apply to be certified as a qualified  
21 business entity if the existing business entity increases the number of qualified positions  
22 as required under subsection (a) of this section for an eligible project in a Tier I AREA or A  
23 Tier II [county] AREA.

24           **(2)** An existing business entity may not be certified as a qualified business  
25 entity unless the business entity:

26                   **(i)** notifies the Department of its intent to seek designation of an  
27 eligible project prior to hiring any employees to fill the qualified positions necessary to meet  
28 the requirements of this subtitle; and

29                   **(ii)** offers an ongoing job skills enhancement training program or  
30 postsecondary education program that is approved by the Department.

31           **(3)** An existing business entity shall submit an application to the  
32 Department containing at least the following information:



1           (i) the number of full-time employees existing before the expansion  
2 and the payroll of the existing employees;

3           (ii) the estimated number of qualified positions to be created and  
4 qualified employees to be hired and the anticipated payroll of the new qualified employees;  
5 and

6           (iii) any other information that the Department requires.

7           (d) A business entity must begin hiring the employees to fill the qualified  
8 positions necessary to meet the requirements of this subtitle within 12 months after it  
9 notifies the Department of its intent to seek designation of an eligible project.

11           (a) The Program benefits authorized under this section may be claimed by a  
12 qualified business entity for up to 10 consecutive benefit years.

13           (b) On enrollment in the Program:

14           (1) a new business entity in a Tier I [county] AREA is eligible for:

15                   (i) a credit against the State income tax, established under §  
16 10-741(b) of the Tax – General Article;

17                   (ii) a credit against the State property tax, established under §  
18 9-110 of the Tax – Property Article;

19                   (iii) a refund of sales and use tax paid during the immediately  
20 preceding taxable year, as provided under § 11-411 of the Tax – General Article; and

21                   (iv) a waiver of fees charged by the State Department of Assessments  
22 and Taxation, established under § 1-203.1 of the Corporations and Associations Article;  
23 and

24           (2) except as provided in subsection (c) of this section, an existing business  
25 entity that operates an eligible project is eligible for a credit against the State income tax,  
26 established under § 10-741(b) of the Tax – General Article.

27           (c) The income tax credit established under § 10-741(b) of the Tax – General  
28 Article is not available to an existing business entity if the entity moves its facility to  
29 another county in the State on or after June 1, 2017.

30           (d) If the number of qualified positions at the eligible project decreases to a  
31 number less than the number established in the first benefit year, the project shall be  
32 removed from the Program and all program benefits terminate.

16 **INFORMATION IS PROVIDED TO THE DEPARTMENT:**

17 (1) **THE DATE OF THE QUALIFIED OPPORTUNITY FUND’S INVESTMENT**  
18 **IN THE QUALIFIED OPPORTUNITY ZONE BUSINESS AND THE AMOUNT OF THE**  
19 **INVESTMENT;**

20 (2) **THE TOTAL PROJECT OR BUSINESS INVESTMENT, INCLUDING ANY**  
21 **LEVERAGE;**

22 (3) **THE ADDRESS AND CENSUS TRACT OF THE QUALIFIED**  
23 **OPPORTUNITY ZONE BUSINESS AND THE QUALIFIED OPPORTUNITY FUND;**

24 (4) **THE NORTH AMERICAN INDUSTRIAL CLASSIFICATION SYSTEM**  
25 **CODE FOR THE QUALIFIED OPPORTUNITY ZONE BUSINESS;**

26 (5) **AN IMPACT REPORT, INCLUDING BOTH QUALITATIVE AND**  
27 **QUANTITATIVE DATA ON THE INVESTMENT AND ITS PROGRESS; AND**

28 (6) **ANY OTHER INFORMATION REQUESTED BY THE DEPARTMENT**  
29 **THAT MEETS THE TRANSPARENCY GOALS OF THE PROGRAM.**
