

## **Instructions for Completing the Concept Paper Perjury Statement**

Each Applicant must provide a signed penalty of perjury statement to assure the accuracy of its application. The person who signs the penalty of perjury statement for the Applicant must have personal knowledge of the facts in the Concept Paper and must be an official who can legally bind the Applicant under state law. Officials who can legally bind the Applicant are an officer on behalf of a corporation, a general partner on behalf of a state law partnership, a member-manager on behalf of a limited liability company, a trustee on behalf of a trust, or the proprietor in the case of a sole proprietorship. Follow these steps to provide the penalty of perjury statement:

- (1) See the template for the perjury statement on the next page (page 2).
- (2) Complete the template by entering the required information where indicated.
- (3) Print page 2.
- (4) Have an official of the Applicant who satisfies the requirements above sign and date the printed page 2.
- (5) Scan the signed page and save it as a pdf file.
- (6) Enter the pdf file containing the completed, signed template in the browse box.
- (7) Upload the file by clicking the Upload button.

If the Applicant is a member (other than the common parent corporation) of an affiliated group filing consolidated tax returns, then the last page of the template (page 3 following) must be completed for the common parent corporation and signed by an officer of the common parent corporation. The officer who signs for the common parent corporation must have personal knowledge of the facts in the Concept Paper. Follow these steps to provide the penalty of perjury statement for the common parent corporation:

- (1) See the template for the common parent corporation's perjury statement on the last page (page 3).
- (2) Complete the template by entering the required information where indicated.
- (3) Print page 3.
- (4) Have an officer of the Applicant's common parent corporation who has personal knowledge of the facts in the Concept Paper sign and date the printed page 3.
- (5) Scan the signed page and save it as a pdf file.
- (6) Enter the pdf file containing the completed, signed template in the browse box.
- (7) Upload the file by clicking the Upload button.
