The application deadline for 2014 second round low income housing tax credit applications was on Tuesday, July 1, 2014. The California Tax Credit Allocation Committee (TCAC) received a total of 88 nine percent (9%) applications and nine (9) four percent (4%) applications (requesting federal and state tax credits) in the second round of 2014. TCAC staff has provided a quick summary of the projects received. As you know, the project information provided on this document is "as applied" in the application and has not been verified by TCAC staff.
