RE: Competitive Tax Credit Applications Received

The application deadline for 2018 first round low income housing tax credit applications was on Wednesday, February 28, 2018. The California Tax Credit Allocation Committee (TCAC) received a total of 61 nine percent (9%) federal credit applications and 8 four percent (4%) applications requesting federal and state tax credits in the first round of 2018. Three of the sixty-one 9% applications are a hybrid structure, including one hybrid requesting state farmworker credit as part of the 4% application. See the following list of the competitive projects received. The project information provided on this document is “as applied” in the application and has not been verified by TCAC staff. **Please review the attached list to assure that if you did submit an application, it is on this list. If you notice that your application is not on the attached list or if there are any errors, please contact your regional analyst as soon as possible.**
