To allow all interested persons a reasonable opportunity to express their views, the Committee encourages the submission of written testimony. The hearing itself will consist of two sequential portions. The first portion will consist of TCAC staff summarizing the proposed substantive changes and answering clarifying questions regarding those proposed changes. The second portion will be the formal hearing wherein comments will be taken for the record. Oral remarks may be limited to no longer than five (5) minutes per person.

Action on the proposed changes to the Market Study Guidelines will be considered after the close of the comment period, December 19, 2018.
