Dear Chairman Brady and Ranking Member Neal:

Over the past few weeks, millions of Americans have been affected, directly and indirectly, by the devastating effects of Hurricanes Harvey, Irma, and Maria. As always, the American family came together to aid one another in the wake of these catastrophes. First responders, law enforcement, and volunteers provided support, rescue, and assistance to those in danger. Immediately after the storm ended, utility workers and volunteers from every corner of our nation went to work to help the storm-damaged communities pick up the pieces. Now begins the slower process of rebuilding, and our citizens expect and deserve the help of their federal government in this massive undertaking.

The U.S. Congress has a long history of stepping up to provide tools and support to its citizens following natural disasters. In 2005, following Hurricane Katrina, in the face of incalculable loss of life and monetary damages exceeding \$108 billion, the Ways and Means Committee collaborated in a bipartisan manner to quickly provide tax relief for those affected and their communities. After the Committee's swift action, the Senate followed suit, and the Katrina Emergency Tax Relief Act was signed into law on September 21, 2005, less than a month after the hurricane made landfall. Having the incentives in place so soon after the disaster helped families, businesses, and localities make practical, informed decisions about the future.

The Katrina tax law acknowledged the necessity of short-term and medium-term supports, and also the importance of accelerating and incentivizing long-term rebuilding. These provisions helped Americans in the hurricane-damaged areas rebuild their homes and businesses and re-establish their lives. The critical tax relief included: provisions to help individual taxpayers access their savings to cope with immediate costs, expensing of clean-up and remediation costs, tax credits and exclusion to help employers and employees to relocate in the hurricane impacted areas, expanded allocations of housing credits to help repair homes and to rebuild affordable housing lost to the disaster, expanded allocations of tax-exempt bonds to finance rebuilding, special work opportunity tax credit designations, and increased allocations of New Markets Tax Credits to spur long-term economic investment.

As you know, Congress expanded this tax relief to apply to communities and families hit by Hurricanes Wilma and Rita to help them make an economic comeback as well. In subsequent years, similar tax relief was extended to tornado victims in Kansas and Midwestern flood victims in several states.


Given the scope of the damage resulting from these recent storms, the tax-writing Committees in the House and Senate should offer assistance consistent with past disasters: a robust and now proven package of tax incentives

to spur rebuilding and recovery. The victims of Hurricanes Harvey, Irma, and Maria – our fellow Americans – need, deserve, and expect our help, and we should not delay our response.


