CY 2016 QAP and Guide Revision – Release of Second Draft

Located on the Department's website (link above) are clean and blackline versions of the **2nd Draft** of the Qualified Allocation Plan and the Multifamily Rental Financing Program Guide for public review and comment. The 2nd draft of the QAP and Guide incorporate changes based on comments received from interested parties in response to the 1st draft issued on February 24, 2016.

The Department is committed to finalizing revisions to the QAP and Guide in a timely manner to enable our partners to continue to pursue the development of critically-needed affordable rental housing, while providing meaningful opportunities for comment and input. Please Note: This is your opportunity to provide comments to the QAP and Guide prior to the release of the final draft.

Monday, June 27, 2016	Deadline for Public Comments to second Draft
Week of July 11, 2016	Release Final Draft of Maryland 2016 QAP and Guide. Publish notice of public hearing and 2 week deadline for receipt of public comments.
Wednesday, July 27, 2016	Conduct Internal Revenue Code (IRC) mandated public hearing for 2016 QAP.
Week of August 8, 2016	Send Final Documents to Governor for signature
