

**Summary of RAD Activity by PHA**

The table below provides a listing of RAD transactions by state and PHA that have been completed or that are in the process of completion, as well as the actual financing that has been raised to support rehabilitation and construction activity (net of "soft" costs e.g. financing fees, professional services, etc). For example, 10 properties in Alabama totaling 1,715 units have completed conversion under RAD and have raised nearly \$24 million (\$14,000 per unit) to improve and replace public housing properties. Construction on these properties is underway or has been completed. An additional 42 properties totalling 7,377 units are in the process of securing their financing, working with residents, and performing all other necessary due diligence necessary prior to completing a RAD conversion and are expected to raise over \$218 million (\$29,500 per unit) to improve and replace public housing properties.

Please note that the numbers below do not include additional reservations under the 185,000 unit cap that HUD has provided to housing authorities for properties needing greater planning and pre-development time. Also, please note that the anticipated construction financing tends to be an under-estimate of the actual construction activity that will be performed.
