The deadline for submission of 2014 Competitive Low-Income Housing Tax Credit Initial Applications is **1:00 PM Central Time on Monday, February 3, 2014.**

Individuals intending to hand deliver one or more 2014 Competitive Low-Income Housing Tax Credit Initial Applications are advised as follows:

1. **LOCATION:** THDA's offices have relocated to the following address:

2. **PARKING:** The following page contains information about nearby parking options. THDA makes no guarantee regarding the accuracy of the information or availability of parking spaces on February 3rd.
3. **ENTRY:** Please use the entry located on 5th Avenue North between Deaderick Street and Union Street.
4. **SECURITY:** At the security checkpoint immediately inside the entrance, you will be required you to show a valid government-issued photo ID and go through a metal detector. All bags, boxes, etc. are subject to search.
5. **DELIVERY:** After passing through the security checkpoint, follow the signage labeled "THDA LIHTC INITIAL APPLICATIONS". **The application submission room will be located in room G225 on the same floor as the security checkpoint.**

Individuals intending to hand deliver one or more 2014 Competitive Low-Income Housing Tax Credit Initial Applications are encouraged to arrive at their chosen parking location no later than 11:30 AM Central Time on February 3rd. Nonetheless, THDA cannot guarantee that this will allow sufficient time to meet the deadline.
