

# ***2010 STATE OF TEXAS PUBLIC HEARING SCHEDULE ON AFFORDABLE HOUSING AND COMMUNITY DEVELOPMENT ACTIVITIES***

The Texas Department of Housing and Community Affairs (TDHCA) announces the schedule for six public hearings to gather public comment on the following topics:
