THESE ARE **NOT** OFFICIAL COMMENTS UNDER THE LAWS AND RULES REGARDING THE RULEMAKING PROCESS. THESE COMMENTS AND SUGGESTIONS WILL BE USED TO GENERATE IDEAS FOR STAFF TO CONSIDER IN DEVELOPING ITS RECOMMENDATIONS TO THE TDHCA GOVERNING BOARD FOR THE 2012 DRAFT QAP. ANY QUESTIONS RAISED IN THE POSTS ARE FOR THE BENEFIT OF THE PARTICIPANTS IN THE DISCUSSION FORUM AND A POSTER SHOULD NOT EXPECT A DEPARTMENT RESPONSE. PERSONS PROVIDING COMMENTS OR SUGGESTIONS ARE REQUIRED TO LIMIT THE SUBJECT OF DISCUSSION TO MATTERS RELEVANT TO THE QAP. PERSONAL ATTACKS, INAPPROPRIATE LANGUAGE, OR THE LIKE ARE NOT ALLOWED. TDHCA RESERVES THE RIGHT TO REVIEW AND SCREEN ANY AND ALL POSTS AND, IN ITS SOLE DISCRETION, DECLINE TO POST ANY MATERIALS IT DEEMS INAPPROPRIATE, UNRELATED, OR OFFENSIVE. ALSO, PERSONS PROVIDING COMMENTS ARE REMINDED OF THEIR RESPONSIBILITY TO REFRAIN FROM POSTING ANY INFORMATION THAT THEY DO NOT WISH TO HAVE MADE PUBLIC, SUCH AS CONFIDENTIAL MATTERS UNIQUE TO THE POSTER OR ANOTHER PERSON.
