Sen. Bill Cassidy, R-La., to Address HTC Community at Novogradac Conference

Novogradac to Host Historic Tax Credit Conference in St. Louis, Sept. 26-27

SAN FRANCISCO— A lead champion of the historic tax credit (HTC), Sen. Bill Cassidy, R-La., will deliver a keynote address to attendees of the Novogradac 2019 Historic Tax Credit Conference, which will be hosted Sept. 26-27 at the Hyatt Regency St. Louis at the Arch.

Sen. Cassidy is a member of the tax-writing Senate Finance Committee, whose amendment helped protect the HTC in the tax reform in late 2017. Sen. Cassidy also introduced the Historic Tax Credit Enhancement Act (S. 3058) in 2018 to eliminate the basis-adjustment requirements of the HTC, a proposal that would enhance the value of HTC transactions and would attract more private capital from investors.

“We’re honored to welcome back Sen. Bill Cassidy as our distinguished keynote speaker for the Novogradac 2019 Historic Tax Credit Conference,” said Michael Kressig, CPA, conference chairman and partner in Novogradac’s St. Louis office. “Sen.
